The parent, guardian, or custodian of a student receiving instruction at a private, denominational or parochial school, or a school choosing not to meet accreditation or approval requirements may also enroll the student in the school district. The student shall be considered under dual enrollment. The parent, guardian, or custodian requesting dual enrollment for the student should notify the superintendent on a form provided by the school district. On the form, they shall indicate the academic courses and extracurricular activities in which the student is interested in participating. Part time enrollment is limited to and governed by:

- Capacity Limits. Enrollment will be subject to capacity limits. Any grade level, program, or course which has been determined to be at capacity for option enrollment purposes shall not be available for non-public school students. The middle school principal and counselor shall also establish capacity limits for particular courses each semester. Students will not be permitted to enroll in courses beyond the established capacity limits.
- 2. <u>Integrated Courses</u>. Students must meet prerequisite requirements to be enrolled in a course by appropriate credits earned through an accredited program. The principal may on a discretionary basis allow prerequisite requirements to be satisfied where the student provides reasonable indications that the academic criteria have been met, such as results from achievement tests or other indications of adequate preparation.
- 3. Educationally Appropriate Programs and Courses. Students will not be allowed to enroll in programs or courses which the school administration determines to not be educationally appropriate for the student. Determination of whether a program or course is educationally appropriate will be made based on the standards the District uses for making academic placement decisions.
- 4. <u>No Partial Part-Time Enrollment</u>. Students must apply for enrollment and attend the entire school year for which enrollment is made or, for high school courses, for the full length of the course. Once enrolled, part-time students will be required to participate in all activities, programs, and tests related to the program or course for which the student is enrolled, including as applicable State or District-wide assessments, as full-time students.
- 5. <u>Transportation</u>. Students enrolled on a part-time basis are not entitled to transportation or transportation reimbursement. Full-time students will be given first consideration for parking on the high school campus.
- 6. <u>Academic Honors</u>. Students enrolled on a part-time basis will not be eligible to graduate or receive a diploma from the District or receive academic honor distinctions including: Honor Roll eligibility, Outstanding Student Awards, National Honor Society membership, Academic Athlete Award or Academic Activity Award.
- 7. <u>Activity Honors</u>. Students enrolled on a part-time basis will be eligible to receive honors awarded for the activity through the school, conference, or state including: Team Captain, awarding of Activity Letters, 3-D Award, All-Conference and All-State awards. Part-time students will not be eligible to receive Athlete of the Year Award or Spirit Award.
- 8. <u>Extracurricular Activities.</u> Students enrolled on a part-time basis may be permitted in the discretion of the principal and athletic director to participate in extracurricular activities. Participation in activities that are subject to the bylaws of the Nebraska School Activities Association (NSAA) will be limited to

those students who meet the district's eligibility policy.

9. <u>Elected Positions.</u> Students enrolled on a part-time basis will not be eligible to hold any elected position including: Student Council Member, Officer in any club or activity, Class Officer, Homecoming Candidate, Frolics Candidate, or Prom Candidate.

A dual enrollment student is eligible to participate in the school district's academic and extracurricular activities in the same manner as other students enrolled in the school district to the extent allowed within NSAA regulations. The policies and administrative rules of the school district shall apply to the dual enrollment students in the same manner as the other students enrolled the school district. These policies and administrative rules shall include, but not be limited to, athletic eligibility requirements, rules governing student conduct, academic eligibility requirements, attendance, and payment of the fees required for participation.

It shall be the responsibility of the superintendent to develop administrative regulations regarding deadlines, specific courses or activities approved, restrictions of classroom space, maximum or minimum course number limitations and other procedures for this policy.
