The **regular** meeting of the O'Neill Public School Board of Education was called to order by President Jim Gotschall at 7:30 p.m., on Monday, January 13, 2014 in the meeting room at 410 East Benton. This meeting was advertised in the Holt County Independent on January 2, 2014 and over KBRX Radio.

Board Secretary Kathy Marvin called the roll with Delight Becker, Ellen Boshart, Gene Chohon, Brad Ducker, Jim Gotschall, and Amy Rowse present.

Administrators Amy Shane, Steve Brosz, Nick Hostert, Dan Woodle, and Kathy Grossnicklaus, were also present. Building and Grounds Director Steve Brown was also present.

Visitors were welcomed and informed that this meeting was in compliance with the Nebraska Open Meetings Act.

The Pledge of Allegiance was recited.

Delight Becker **moved**, **to approve the meeting agenda**. Gene Chohon **seconded** the motion. Roll call vote **carried** 6-0. Voting Aye: Boshart, Chohon, Ducker, Gotschall, Rowse, and Becker.

Brad Ducker moved, to approve the minutes of the December 16, 2013 regular meeting as presented without reading. Ellen Boshart seconded the motion. Roll call vote carried 6-0. Voting Aye: Chohon, Ducker, Gotschall, Rowse, Becker, and Boshart.

## Negotiations

Ellen Boshart moved, to approve the 2014-2015 Negotiated Agreement as presented with a base salary of \$30,925 and moving to a \$950 insurance deductible. Delight Becker seconded the motion. Roll call vote carried 6-0. Voting Aye: Ducker, Gotschall, Rowse, Becker, Boshart, and Chohon.

## Contract with Unified District #1 for the 2014-2015 School Year

Ellen Boshart moved, to enter into a contract with Unified District #1 as presented, for instruction at the Center for Teaching and Learning for the 2014-2015 school year. Gene Chohon seconded the motion. Roll call vote carried 6-0. Voting Aye: Gotschall, Rowse, Becker, Boshart, Chohon, and Ducker.

President Gotschall adjourned the meeting Sine Die for election of officers at 7:40 p.m. The meeting was called back to order by Superintendent Shane at 7:41 p.m. Board members present were Becker, Boshart, Chohon, Ducker, Gotschall, and Rowse.

### **Election of Officers**

Superintendent Amy Shane called for nominations for President. **Amy Rowse nominated Jim Gotschall for President**. With no other nominations forthcoming, nominations ceased. Roll call vote for Jim Gotschall for President **carried** 6-0. Voting Aye: Rowse, Becker, Boshart, Chohon, Ducker and Gotschall.

President Jim Gotschall called for nominations for Vice President. **Brad Ducker nominated Delight Becker for Vice President**. With no other nominations forthcoming, nominations ceased. Roll call vote for Delight Becker for Vice-President **carried** 5-0-1. Voting Aye: Boshart, Chohon, Ducker, Gotschall, and Rowse. Abstaining: Becker.

President Jim Gotschall called for nominations for Vice President – Elect. Ellen Boshart nominated Brad Ducker for Vice President – Elect. With no other nominations forthcoming, nominations ceased. Roll call vote for Brad Ducker for Vice President – Elect carried 6-0. Voting Aye: Boshart, Chohon, Ducker, Gotschall, Rowse, and Becker.

Gene Chohon moved, to appoint Kathy Marvin as School Board Secretary. Amy Rowse seconded the motion. Roll call vote carried 6-0. Voting Aye: Chohon, Ducker, Gotschall, Hull, Rowse, and Boshart.

The appointment of School Board Treasurer was tabled until the February School Board meeting in order to obtain additional information regarding the responsibilities and duties of the treasurer.

Brad Ducker moved, to authorize Amy Shane, Superintendent; Steve Brosz, Principal; Nick Hostert, Activities Director; and Cheryl Ludwig, Activities Secretary to sign checks for the Activity Account. Amy Rowse seconded the motion. Roll call vote carried 6-0. Voting Aye: Rowse, Becker, Boshart, Chohon, Ducker, and Gotschall.
