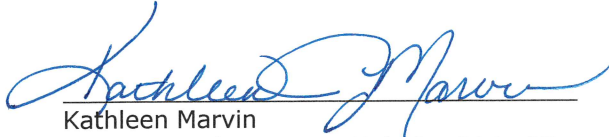
Building principals shared the variety of ways students observed required holidays and events.
